Dear SCCS Families,

Today, we begin the next step in preparing for the 2021-2022 school year at St. Croix Catholic with re-enrollment of our current students. It is always an exciting time of year- looking toward a new beginning! As explained last year, while it may seem early for re-enrollment, having accurate numbers now allows us to see how many new students we can accept and how many sections of each grade we will have. From there we then move forward with other planning- tuition assistance awards, next steps with our current programs and academic projects such as those mentioned in my State of the School, staffing needs, etc. We've covered some great ground these last few years because we have had more time to carefully and reflectively plan, for this we can be proud!

All of this being said, please remember that the re-enrollment window that opens today will close on **Wednesday, January 13**. *SCCS cannot guarantee seats for current students who are re-enrolled after this date.* We also ask that all Financial Aid Applications be submitted through TADS by January 13.

All current SCCS Families with a child(ren) currently in Preschool through 7th Grade will be receiving an email from TADS today prompting you to complete your family's agreement. In working to streamline our processes, this step will only take a few minutes as all student and family information has already been rolled forward in TADS. Further, in streamlining re-enrollment, SCCS will no longer need to prompt families to sign a separate tuition agreement in the spring. A few important notes:

- Please read the Agreement carefully as, in addition to other details, it includes previously mentioned information such as: the Continuous Enrollment policy, our annual withdrawal fee schedule, various Terms & Conditions, and an explanation of how and when Tuition Agreements will be adjusted in the cases of awarded tuition assistance;
- SCCS automatically applied multi-child scholarships discounts, K-8, for families who made this selection for the 2020-2021 school year. **If you did not choose this option and would like to do so for the 2021-2022 school year, or if we applied the multi-scholarship and you would like to either pay regular tuition or plan on applying for financial aid, please contact Kassy Rogers at krogers@stccs.com, before completing the agreement. Ms. Rogers will immediately make that adjustment so that you are still able to sign the Agreement by January 13.**
- You will also find in your TADS account that families have been billed the \$100 per student Registration Fee. This fee will be applied to the 2021-2022 school year tuition provided that the Agreement is completed by January 13 and the Registration Fee is paid by February 1.
- As previously communicated, the Board of Directors has approved the discontinuation of SCRIP rebates being used as tuition credits. Therefore, the \$325 per family SCRIP requirement has been removed from the agreement.

Below you will find the tuition rates, Preschool through 8th Grade, which have been approved by the Board of Directors for the 2021-2022 school year. In our budgetary planning to date, we are estimating that the overall cost to educate a kindergartener through 8th grader at SCCS will be approximately \$7,771.

As emphasized in the State of the School presentation, enrollment numbers and tuition dollars are the driving force for budgetary decisions, which ensure that we have excellent staffing and programming at St. Croix Catholic School. Since tuition dollars are the primary revenue source for budgetary decisions, which are made in the spring for the upcoming school year, the Board of Directors has approved the following adjusted schedule of fees for withdrawals, Preschool through 8th Grade, as they apply to the 2021-2022 school year.

Withdrawal Fees

February 15, 2021 to March 31, 2021	25% of adjusted* tuition per student
April 1, 2021 to December 31, 2021	50% of adjusted* tuition per student
January 1, 2022 or later	100% of the adjusted* tuition per student

**The adjusted tuition obligation is defined as tuition per student after any applicable tuition assistance or scholarship has been applied.*
